RESOLUTION WITHDRAWING THE MEMBERSHIP OF PAWD TO THE PHILIPPINE WATER WORKS ASSOCIATION (PWWA) EFFECTIVE JANUARY 1, 2011

Resolution 43, s. 2010

“WHEREAS, the Philippine Association of Water Districts, Inc. (PAWD) has been an institutional member of the Philippine Water Works Association (PWWA) for several years now;

WHEREAS, as a member thereof, PAWD has actively participated and supported PWWA in all its programs and activities;

WHEREAS, PAWD has likewise encouraged the membership of water districts in PWWA, as supported by the fact that the water district sector remains the single biggest group that comprise the PWWA membership;

WHEREAS, in acknowledgment of this fact, Section 3, Article IV of the PWWA By-Laws provides that PAWD shall be accorded with three (3) representatives to the PWWA Board of Directors, namely: the PAWD Chairman, the PAWD President and another representative who will be designated by the PAWD Board of Governors;

WHEREAS, in the recent amendment to the PWWA By-laws, the representation of the PAWD to the PWWA Board of Directors has been reduced to one;

WHEREAS, the diminution in the number of representation of PAWD to the PWWA Board of Directors does not sit well with the PAWD considering the number of water district membership in the PWWA;

WHEREFORE, on mass motion of the members of the Board of Governors, be it –

RESOLVED, AS IT IS HEREBY RESOLVED, to withdraw the membership of the Philippine Association of Water Districts, Inc. (PAWD) from the Philippine Water Works Association (PWWA) effective January 1, 2011;

RESOLVED FURTHER, that copy of this resolution be furnished the leadership of PWWA, all water districts thru the Regional Associations, for their information;

UNANIMOUSLY APPROVED, this 24th day of September 2010 at the Top Plaza Hotel in Dipolog City.”
